## FROM THE RECTOR'S STUDY

Happy New Year! I know many are glad to see 2021 come to a close and are hoping and praying for a better 2022. No doubt, as the pandemic continued in 2021, most folks are feeling a bit run down from dealing with it for close to two years now.

As I look forward to 2022, I look forward to some of the goals I have for us at Good Shepherd Church. One of those goals I'd like to share with you in this column. In 2022, I along with lay leadership, will take on the task of rewriting our church's bylaws. I realize that just the mention of this task causes many an eye to simply gloss over. But it is work that must be done for the betterment of the parish.

One of the things we will be examining as leaders is what constitutes an appropriate number of leaders on our Council. When Good Shepherd Church was founded in 1976, ten members seemed to be a good number. These were folks who were placed up for consideration by a nominating committee and then elected to serve by the membership. Many things have changed since 1976 and as has been discussed at Council in recent years, ten members may no longer be a good number.

One of the things we learned in the early months of the pandemic, when the world was seemingly shut down and meetings were simply not a possibility, was the reality that leadership still needed to make decisions and act on behalf of the local church. Much of this fell upon what is called the Executive Council which is made up of the pastor and the four primary officers of the Council. A smaller, leaner, more nimble leadership board will likely be a part of the new bylaws in 2022.

In past years our nomination committee has faithfully served to fulfill their role of nominating members for vacant positions on Council. Much of the time, this seems to have resulted in previous members of Council simply being renominated and reelected to a new Council. While we are blessed to have many members who do not mind being "recycled" on to Council, one of the weaknesses of this mode of operating has been that the Council has never adequately communicated to the nomination committee exactly what sort of leadership is needed on Council. Thus, another likely change in the new bylaws will call for Council members to prayerfully discern exactly what gifts and talents are needed within the leadership body and then to actively seek to recruit, disciple, and equip others from the membership body to replace them. Rather than a nominating committee serving as a middle step to new leadership without any knowledge of what exactly is needed by the leadership body, the leadership body itself will be charged with identifying gifts and talents that will be missing as particular Council members cycle off of the leadership and intentionally seeking to replace those leaders with new leaders who bring to the table skill sets, gifts, and talents that are truly needed by the organization.

Our new bylaws will have to be carefully crafted so as to make certain we are not in violation of any canons of our province (the ACNA) or our diocese (Diocese of the Western Gulf Coast). As our bylaws currently read, we are actually out of compliance with **ACNA Title 1**, **Canon 6**, **Section 5 – Concerning Boards**, which states:

There shall be a governing board of each congregation, often known as the vestry, which is chosen and serves according to applicable laws, diocesan canons, and the congregational by-laws. The Presbyter in charge of the congregation shall always be a member of the governing board and its presiding officer except as provided by diocesan canon. The governing board is responsible for the temporalities of the congregation and, except where otherwise provided by canon, supports the clergy in the spiritual leadership of the congregation.

The end of one thing always brings about the start of something new. As I write this column in the final days of 2021, I do so looking forward to the start of something new in 2022 and I do so with a newfound sense of excitement. Why do I say that? Perhaps like me, you have found the past two years to have been a time of feeling constrained by all that couldn't be done. My resolution for 2022 is to focus on what CAN be done, prioritizing what NEEDS to be done, and teaming with folks here at church who WANT TO GET IT DONE. I pray you'll be in that number!

Until next month, let your light shine!


### SUNDAY CELEBRATIONS & REMEMBRANCES AND

Let us know by filing out the blue "Sunday Cel-

ebrations, Honors, and Remembrances" form.

The "Sunday Celebrations, Honors, and Remembrances" form is available in the narthex of the church. By completing the **brief form** with the necessary information (e.g., John and Jane are celebrating 20 years of marriage on June 15 or Mike and Sue wish to honor the memory of Sue's mother, Pauline on what would have been her 100th birthday) and turning it in along with **a small \$5 honorarium**, you can be assured that the Sunday of your choosing includes the publication of your



honor in our Sunday bulletin and prayerful remembrance during our Sunday service.

Additionally, the **2022** book is now opened for sponsoring the **Eternal Flame Sanctuary Lamp**. If you would like to dedicate the Eternal Flame in memory of a departed loved one, please see the open dates in the red folder in the narthex. ### PRAYING AN ACT OF SPIRITUAL COMMUNION

Since the COVID-19 pandemic lockdown began, Good Shepherd Church has been streaming our 10:00 AM Sunday morning Service of Holy Eucharist each week. During the distribution of Holy Communion, the lector reads a prayer entitled **An Act of Spiritual Communion** for those who are watching at home and are unable to partake in the reception of Holy Communion sacramentally. That beautiful prayer comes from the Book of Common Prayer (pg. 677, ACNA 2019) and can be prayed by a Christian any time they are longing for the grace of Holy Communion but are unable to receive the tangible elements of the sacrament. These are the words to that prayer:

Dear Jesus, I believe that you are truly present in the Holy Sacrament.

I love you above all things, and I desire to possess you within my soul.

And since I cannot now receive you sacramentally, I beseech you to come spiritually into my heart.

I unite myself to you, together with all your faithful people gathered around every altar of your Church, and I embrace you with all the affections of my soul.

Never permit me to be separated from you. Amen.
